



## Global Dominican Academic Exchange at the University of Georgia School of Law Transnational Law Program Information

## **Program Description:**

The Global Dominican Academic Exchange Transnational Law Program at the University of Georgia (UGA) School of Law is a collaborative effort between InteRDom, a program of Global Foundation for Democracy and Development (GFDD), and the University of Georgia School of Law. The program will bring Dominican law students and young professionals to UGA Law for 9 days, where they will participate in a rigorous certificate program that introduces the American and international legal systems and education through a variety of courses and social and networking activities.

Dominican participants will join other students from international universities who are jointly participating in the program. In addition to their exposure to American legal education, participants will experience academic and campus life and enjoy social events designed to inspire multicultural exchange and intellectual conversation with students and Georgia Law professors at one of the major research universities in the United States. It provides a unique opportunity for academic and cultural exchange and growth between Dominican and international participants and UGA Law LL.M. and J.D. students. During their studies at Georgia Law, participants will also have access to the Alexander Campbell King Law Library and will be able to join the Georgia Society for International and Comparative Law, a student-run organization that organizes international opportunities for member students and which will host a mixer for all program participants and current J.D. and LL.M. Georgia Law students at the conclusion of the program.



The courses offered through the program include:

- International Law by Professor Diane Marie Amann, holder of the Emily and Ernest Woodruff Chair in International Law;
- Introduction to US Constitutional Law by Professor Randy Beck, holder of the Justice Thomas O. Marshall Chair of Constitutional Law;
- Introduction to US Criminal Law by Professor Julian Cook;
- Introduction to US Corporate Law by Professor Usha Rodrigues; and
- Introduction to U.S. Environmental Law by Professor Peter Appel who was named the Alex W. Smith Professor of Law in 2011.

Formal academic study will be 15 hours total, therefore an F1 (student) visa is not required to participate in this program. However, a valid US tourist visa is required.

Participants will be lodged in double-occupancy hotel rooms at a special rate near the university, and will have free time to explore the beautiful campus, quaint downtown Athens and surrounding towns for shopping and sightseeing, and/or enjoy the renowned music scene in the area.

The Transnational Law Program is an initiative of the <u>Dean Rusk Center for International Law and Policy</u> aimed at bringing law students from foreign universities to study at Georgia Law for one to two weeks, providing a flexible curriculum and exposure to American legal education.
